## Treasure's-Financial Report: Judy

A donation of \$2500.00 was initially attributed to "Reserved for Ruger Ranch" and should be changed and attributed to the "Multi-Purpose Building", as requested by the donor. The Ruger Ranch donation balance should now read \$700.00.

An additional \$1000 donation was received for the purpose of the Weaver Mountain Regional Facility/Multi-Purpose Center.

**Land Donation Proposal:** A motion was made to accept the Maughn Ranch land donation with the following statement/addendum to be put in the contract with Maughan Ranches: "Motion to proceed to contract for the land donation by Maughan Ranches with the stipulation that Peeples Valley Fire Department and Auxiliary is able to meet the obligations #1-4 of the proposal."

The following information describes Proposal Items #1 - 4 in detail:

Proposal Item #1: Survey the 10 acres of donated land (This is a portion of parcel 202-04-004F) will cost \$2600.00, with half (\$1300.00) due up front. The balance will be due after the survey is done. The survey should be done by the end of Jan. 2024.

Motion to approve monies for the survey made by: Marcie Second: Kelley Vote: Approved: 17-0

Proposal Item #2: Install cattle guards at West Double Bar A Ranch Road and South Sickles Ranch Road. The cattle guards will be provided by Maughan Ranches(Donor). PVFD-Auxiliary is getting quotes for the work to install the cattle guards. The cost of this item will be funded by donations that are in process.

Proposal Item #3: Install fencing at both the south and east portions of the newly created property boundaries. This work will be funded by donors (approximately \$35,000.00). This fencing, at a minimum, will be four-wire ranch fencing.

Proposal Item #4: Provide an appraisal for the donated property for tax purposes. The cost of this item will be funded by donations that are in process.

Additionally, once the land survey is completed, the matter of re-establishing drainage related to the property will be researched.

Karen recommended that a Special Committee be formed of members of the Community who bring relevant expertise to advise and support us with the next steps involved in pursuing the current land transfer proposal and its future development. The committee will provide regular updates and recommendations for action no less than monthly prior to the monthly Auxiliary meeting.

A motion was made to form this Special Committee (to be named, the Weaver Mountain Regional Facility Property Committee"). Karen and Chief Bomar will appoint members to this committee, and members of the Auxiliary, while welcome to the meetings, are not required to attend them. Motion made by: Angie D. Second: Lori Vote: Approved: 17-0

The first meeting for this Special Committee is to be held on January 15<sup>th</sup>, 2024, at 10AM at the Historic School House.

Judy also reminded us that with this size of a donation, we will need to consider budgeting for accounting expenses when it is time for us to prepare our 2024 taxes.

#### **Committee Reports:**

Community Outreach & Membership Committee:
