- ❖ Grants: AZDFFM Hazardous Fuels has been applied for. Continuing Safer Grant with Southern Yavapai Fire. AFG Grant for Fuels Reduction Equipment still pending. PAWUIC Title Three Grant Awarded. Arizona Community Foundation Grant for communications awarded.
- Personnel/Training: Currently have 25 volunteers (9 of which are EMTs). One engine, the tactical tender, and 6 personnel are currently out on wildfires.
- Irwin Status: 6 are available.
- Apparatus/Equipment: All apparatus and equipment are operational.
- Wildfire Mitigation: Mitigation efforts are being conducted on private property. Due to severe fire danger, the Mitigation Crew are restricted from using any motorized equipment.
- Water Resources Along Highway 89: The installation of dry hydrant at Hidden Springs is pending.
- Additional Hydrants. Once the two new hydrants get installed, a new ISO status will be requested by the PVFD.
